Thank you for your interest in becoming a member. Please note the eligibility requirements outlined below. All of the information requested on the form below (with the exception of phone number and e-mail address) is required to determine if you qualify for membership. However, only your name and address will be included on the membership mailing list and all other information will be kept in our general administrative files.

### MEMBERSHIP ELIGIBILITY INFORMATION

**OCF BYLAWS, ARTICLE 5**

2. **Eligibility and Admission.** Any individual who subscribes to the purposes and basic policies of the Fair, who is registered with the Fair, and who has participated in one of the two previous years as a volunteer, worker, performer or booth participant may be deemed a member provided they abide by the terms and conditions of these bylaws, the Articles of Incorporation and any amendments thereto, and act in accordance with the decisions made by the Board of Directors.

6. **Voting.** All members who have been members for at least 30 days prior to the date of a membership meeting shall be entitled to cast one vote on any issue brought before the membership. Members shall vote to elect the Board of Directors, recall a director, amend the Articles of Incorporation and on all other matters for which a membership vote is required by the Oregon Revised Statutes and by these bylaws. In addition, members shall have the right to vote on advisory resolutions concerning any other matter to come before the membership.

**PLEASE NOTE:** There are two separate lists that you can apply to be on with this form: (1) the **membership list**, for which you must meet membership eligibility requirements; and (2) the **newsletter mailing list**, which includes the minutes of the OCF Board of Directors meetings. If you want to be a member AND receive the Board minutes, check both boxes below. If you want to be a member but don't care to receive the minutes, check the Membership Application box only. You can receive Board minutes even if you aren't a member; just check the Newsletter Mail list box below.
